## Mission Trip Policy Agreement

**I agree to the following outlined policies as a mission trip team member in accordance with Global Hope India.**

1. As a representative of Jesus, the United States and Global Hope India, I will behave at all times in a manner that brings glory and honor to these institutions. I also will respect and follow the trip leaders and group leader and his/her decisions.
2. I am aware that every word and action is being watched during the entire mission's trip experience. Therefore, I agree to act and talk in a manner that glorifies the name of Jesus Christ. I want everything I do or say to draw people to Jesus.
3. I will be spiritually, physically, and mentally prepared for a mission trip that will stretch me and mold me in ways I can only imagine. I will do everything I can ahead of time to prepare myself for a "trip of a lifetime."
4. I am a guest in the country I am visiting. I will respect and follow the traditions of the local people and nationals. For example: if the way I dress offends them, I will change.
5. I have come to learn from the people I am visiting. I will not criticize the culture, efficiency, work habits, food, traditions, etc with which I come in contact with. I have not come to judge, but to learn and share the person of Jesus through my words, actions and deeds.
6. I agree to have a servants attitude at all times. When I am doing a task or ministry I don't particularly care for, I will put my best foot forward and be a witness in this activity and in everything I will participate in while on this trip.
7. I will use words that encourage and build up my team members and the residents at all times. This means I will refrain from gossip or words that bring dissention and take away from goals of the trip
8. I will have a positive attitude at all times. Every trip has its challenges and unforeseen circumstances. People could get sick, items lost or stolen, and plans changed. I realize that there are times I will need to "roll with the punches" and look at challenges as opportunities and not obligations.
9. I will work with all members of the team. I will not pursue romantic relationships during the trip. If my spouse or significant other is with me on the trip with me, I will make every effort to spend time with each person of the group and interact with all team members. I realize that sleeping accommodations most likely will not allow me to stay in the same room as my spouse. Men will be in rooms with men and women with women.
10. I will attend all meetings and fulfill the responsibilities I have agreed to before, during and after the trip. If an emergency prevents me to honor an obligation, I will contact the team leader as soon as possible to work out a resolution.
11. I will be willing, as necessary, to abstain from consuming alcohol or using tobacco products while on the trip.
12. I will not use illegal drugs before or during the trip.
13. I will not steal or commit any crime or do anything illegal while on the trip.
14. I will follow the travel, supply, clothing, financial, medical guidelines etc. set forth and explained to me prior to the trip.

I realize that to attend this trip and represent Jesus on the mission field is a privilege and violation of this privilege constitutes the right for my trip to end prematurely.

### **Trip Participant Waiver & Release Agreement**

In consideration of the undersigned's application for participation in a mission trip sponsored by Global Hope India, of Raleigh, North Carolina and as an inducement to organizing the mission trip and permitting the undersigned's voluntary participation as follows:

The undersigned hereby fully and forever releases and waives and agrees not to cause to be brought any and all claims, demands, actions, or causes of action of every possible kind and nature whatsoever the under-signed might assert, including, without limitation, claims for personal injury, wrongful death, or property damage, whether or not absolute, known or unknown, or otherwise against Global Hope India or any of its board members, officers, employees, agents and volunteers (collectively referred to herein as the "Releasees") by reason of, arising out of or relating to the undersigned's participation in a mission trip. The undersigned hereby acknowledges that certain risks are inherent when embarking on a trip such as this. These risks include, but are not limited to, physical illness, kidnapping/abduction, assault, transportation accident, animal bite, and/or heat exhaustion/ stroke.

The undersigned further agrees to indemnify, defend and hold the Releasees harmless from damages, including, without limitation, special, incidental and consequential damages, losses or expenses suffered or paid, directly or indirectly, as a result of any and all claims, causes of actions, suits, proceedings, demands, otherwise, assessed, incurred or sustained by or against the Releasees by reason of, arising out of or relating to the undersigned's participation in this mission trip.

The undersigned further agrees that this Wavier and Release Agreement (the "Agreement") is binding upon the undersigned's heirs, executors, administrators, assigns and legal representatives; that this Agreement releases all successors, assigns and legal representatives of the Releasees; and that this Agreement is to be governed by the law of the State of North Carolina.

The undersigned further agrees that the execution of this Agreement is continuing in nature; it is the undersigned's knowing and voluntary act; the undersigned does not intend to participate in the mission trip until and unless the undersigned has had full opportunity to the undersigned's satisfactions to inspect and determine the scope of the mission trip and receive all information from the leader or Mission Department which bear on the undersigned's decision to participate; and the undersigned is under no duress or undue influence to execute this Agreement.
